Dear Madam Clerk:

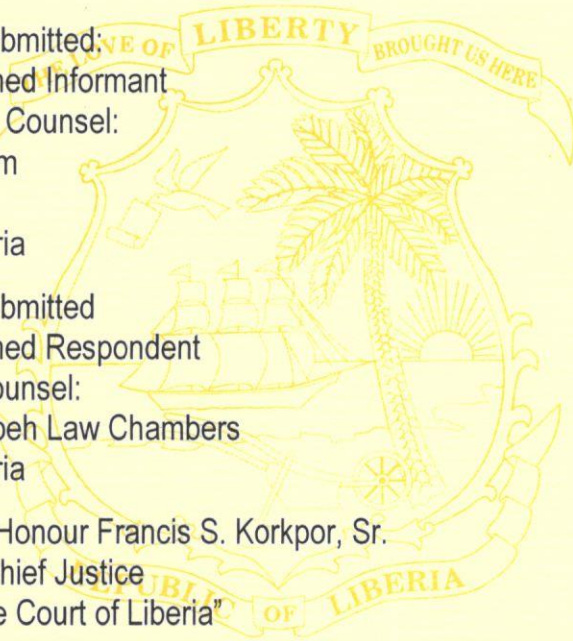



ADJUDGED:


