Wednesday, April 4, 2018 5th DAY'S SESSION

The Honorable Supreme Court of the Republic of Liberia, sitting in its March Term, 2018, met this morning at the hour of 10:00 a.m., for the transaction of business with His Honor Francis S. Korkpor, Sr., Chief Justice, presiding.

OFFICERS OF COURT PRESENT.

<u>COUNSELLORS PRESENT</u>: J. Emmanuel R. Berry, L. Koiboi Johnson, Arthur T. Johnson, Swaliho A. Sesay, Nyenati Tuan, Charles Abdulai, J. Daku Mulbah, Tiawan S. Gongloe, Stanley Kpakillen, James C. R. Flomo, Golda E. Bonah Elliott, Edwin K. Martin, Sylvester D. Rennie, Peter W. Howard, Bhator Holmes Varmah, David W. Woah, and G. Moses Paegar.

His Honor Francis S. Korkpor, Sr., ordered and the Marshal cried the opening of the day's session. Thereafter, the Court was led in devotion by Alhaji Mustapha Wollor Momoh, Assistant Chaplain, Supreme Court of Liberia.

A motion for the correction and adoption of the minutes of Tuesday, March 27, 2018, 2nd day's session, and Wednesday, March 28, 2018, 3rd day's session, was made by Counsellor Tiawan Saye Gongloe of the Law Offices of Gongloe & Associates, Inc., and seconded by Counsellor G. Moses Paegar of the Sherman & Sherman, Inc.

The following corrections were made to the minutes of Tuesday, March 27, 2018, 2nd day's session, and Wednesday, March 28, 2018, 3rd day's session, by the Bench and the Bar:

- 1. Corrections of the minutes of Tuesday, March 27, 2018, 2nd day's session:
- Page 2: "RESISTANCE: 'Counsel for 2nd respondent/ co-appellee, Gonpue Kargon, objects to the consolidation of both the motion and the appeal, same being that our law does not support the taking of an appeal from the implementation of a Supreme Court Mandate'."

- Page 3: "THE COURT: '.... We see that the bill of information filed by the appellant as well as the appeal brought to us from the conduct of the re-examination ordered by this Court presents similar issues of law and facts'."
- 2. Corrections of the minutes of Wednesday, March 28, 2018, 3rd day's session:
- Page 3: "Ans: Yes, Your Honors. But The Supreme Court has ruled in a number of cases that the failure of an appellant to transcribe the records to the Supreme Court constitutes an abandonment of the matter."
- Page 4: "THE COURT: "The record in this case is not complete. The appellants did not transcribe the record from the lower court to allow the Supreme Court receive the record. The movant/appellee is urged to transcribe the records so that the Court will have the entire records. The expenses made by the appellee will be passed to the appellants for reimbursement. The case out of which this motion grew will be assigned for hearing two weeks from today. And it is so ordered. Matter suspended."

THE COURT: "With the corrections made by the Bench and the Bar, the minutes of Tuesday, March 27, 2018, 2nd day's session, and Wednesday, March 28, 2018, 3rd day's session, are adopted."

And respectfully submits."

THE COURT: "The Court will allow the re-assignment of the hearing of all the cases assigned for today, Wednesday, April 4, 2018, because the lawyers representing the parties are not ready for the hearing of the cases. The counsels are advised to file their respective briefs on or before the close of the working day on Friday, April 6, 2018. The cases will be reassigned based upon notices of assignment. And it is hereby so ordered. Matter suspended."
