## JUDGMENT

When this case was called for hearing, Counsellors Augustine C. Fayiah and T. Joseph Debbleh appeared for the appellant. Counsellor Wesseh A. Wesseh of the Ministry of Justice appeared for the appellee.

Having heard the arguments, reviewed the facts and circumstances revealed by the records, and examined the laws controlling, it is hereby

## ADJUDGED:

That in a criminal case, the right of the accused to produce evidence, confront witnesses against him, not to produce evidence against himself or to compel appearance of witnesses to testify for him are constitutionally protected rights pursuant to Article 21(h) of the Liberian Constitution (1986); therefore, the trial court committed reversible error when it denied the appellant from testifying for himself.

WHEREFORE and in view of the foregoing, the final ruling of the trial court is reversed and the case is ordered remanded for a new trial. The Clerk of this Court is ordered to send a mandate to the court below commanding the judge presiding therein to resume jurisdiction over this case and enforce this Judgment. Costs are disallowed. AND IT IS HEREBY SO ORDERED.
